Emergency Reporting (ER) is a powerful online system where authorized first responders access Fire & EMS reporting and records management services to enter incident reports, maintain resources, generate community risk assessments, store prefire plans and occupancy inspections, and much more.

Emergency Reporting supports over 750,000 first responders with a cloud-based, secure, easy-to-use records management solution (RMS). Emergency Reporting is hosted in the highly reputable and secure Microsoft Azure Government data center, operating within isolated data centers and protected networks separated from general networks.

Emergency Reporting federal customers within the Department of Defense, Department of Energy, and Department of Veterans Affairs (VA) are all required to maintain compliance with stringent cybersecurity guidelines. To meet those guidelines, the ER Federal Package, Ultra Secure, provides the following benefits:

- Security certifications for server hosting, including FedRAMP high-level certifications, NIST 800.171 (DIB), ITAR, IRS 1075, DoD L4, and CJIS
- Single Sign On (SSO) integration allows customers to operate their own Identity Provider (IDP). Implement any login require ments for additional security, including CAC cards
- Risk Management Framework (RMF) compliant
